Despite repeated attempts to engage the Investment Managers, they have remained entirely unresponsive and untraceable, failed to file statutory returns or maintain records, and allowed operational lapses that have impeded distributions and redemptions —material breaches that render the continued operation of the Funds impracticable and adverse to investor interests.
